Overview

Matthew H. The BBO is an independent administrative body established by the Supreme Judicial Court to investigate and evaluate complaints against attorneys. Hearing Officers sit in panels of three as fact-finding tribunals in disciplinary proceedings brought against individual attorneys by the Office of Bar Counsel. They hear testimony, take evidence, make adjudicatory rulings and, with the assistance of a Board attorney, prepare written reports and recommendations for the Board of Bar Overseers.
